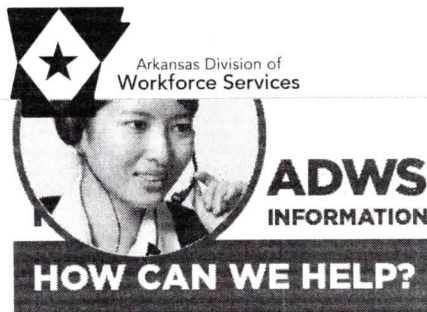

The Arkansas Workforce Development Board (AWDB) is seeking public comments on *Arkansas' Unified Strategic Workforce Development* (State Plan) 2020-2023 Modification. The four-year State Plan represents an agreement among the core partners identified in the *Workforce Innovation and Opportunity Act (WIOA)* and serves as the framework for developing public policy, fiscal investment, and operation of all state labor exchange, workforce education, and training programs. The U.S. Department of Labor requires states to review and submit modifications to their State Plans at the two-year point that reflect any changes in the labor market and economic conditions, or other factors affecting implementation.
